# From One Person in the U.S. to the Others

How do we respond to the ferocious and unjustifiable acts of terror on September 11? Some people -- starting with the pResident and the media -are whooping and hollering for "war," but I don't buy the polls that claim virtual unanimity for seeking military revenge and retribution. What the pollsters are really asking is, "Do you think the people who did this should get away with murder?" and of course 99.9 percent of people say "No!" But look into your own heart. In addition to anger, we are experiencing pain, grief, loss, bewilderment, denial -- all the stages of contradictory emotions that you go through when somebody you care for dies, written 10,000 times larger.

It's only natural that we want to pull together for support and comfort, to deal with strong and disturbing feelings of powerlessness that came out in response to the shocking attacks, death and destruction. But George Bush and his plans for war are a slim reed on which to hang our desire for unity and security. It is up to us, the people ourselves, to put forward a positive, humane, and effective vision, at a moment of anguish and danger. Military force will feed terror, not defeat it, and in the process it will grind up and destroy the last of the freedom, creativity and hope for a better world that we rightly value.

I am just one person, a teacher and union member, a parent, who cannot command the attention of the media or the battalions of the largest military machine on the planet. But I know the average person has a much more complicated and really more profound set of reactions to what has happened. I know that, as I and others have gone out in these days since the attack with a message of peace, justice and solidarity, against war and racism, we have drawn a great deal of support and interest.

For each of us, in dealing with our feelings, with our ideas, or with questions about how to combat terror, there is a lot of sorting out to do. If we are each divided within ourselves, what part of ourselves should we unite with? What should we reconsider? The contradictory feelings and ideas we are experiencing are manifestations of deeper contradictions within our society and our selves, contradictions between privilege and oppression, between aspirations and reality. We must begin to resolve these contradictions to deal with the situation that we now find ourselves in, and we must begin by abandoning the illusions and self-deceptions that died with the thousands on September 11. We have refused to confront the terrorism that we have harbored in our own midst; we have depended on the trappings of imperial might for security, and they have failed us. We can no longer refuse to face the contradictions in our history and society.

machine wages war and buys 'security' by means of invading and subjugating other nations while infiltrating and regimenting U.S. society itself? Nobody except the politicians and corporations that have too much power already.

We are all looking for answers amid the confusion. This, too, can be a good thing, a recognition that we have left ourselves in the dark about what's going on in the world. Some of us have been glued to the tube or the PC monitor for days, afraid we will "miss something." Of course, we have already "missed something," we let the dangling fruit and distractions of material striving and temptation blind us to the darkening forest of thorns growing in the soil of America. The failure of "intelligence" was not only on the intelligence

agencies. Our media have screened out information and opinions that might make people uneasy. As more and more power and wealth has accumulated in fewer and fewer hands in this country, the acceptable spectrum of opinion or dissent has narrowed as well. We the people have been closed out of the political process along with any ideas and challenges that are considered subversive of the established order.

So to find answers, we must examine the facts and ideas that have been forbidden, or hidden by self-imposed blinders. History did not begin on September 11 any more than it had ended with the fall of the Berlin Wall. The U.S. was involved in wars to build and maintain an empire long before the Cold War. It has remained involved in such wars for the decade-plus since the Cold War ended and the communist bloc vanished.

In fact, the U.S. has been at war, with Iraq, over that entire latter period. Few of us took any notice as our government went about destroying Iraq's potable water system, bombing that country regularly. The U.S. maintains an area of military over-flights over Iraqi territory while simultaneously enforcing that as a zone in which the Iraqis cannot fly over their own territory, and of course enforcing an embargo which has cost hundreds of thousands of lives. We could ignore or deny that war (as Bush did in calling his declaration the "first war of the 21st Century"); but we cannot deny this one.

Yet we must oppose it and refuse to allow George W. Bush to wage it in our name. We must recognize that the U.S.

government has other fish to fry beyond the war against terror it has proclaimed. From the moment the old Soviet Russian empire collapsed, the U.S., as the world's only super-power, has had its eyes set on filling the power vacuum and advancing its military power to control the oil wealth of the Caspian Sea and Central Asia. This is the same script we followed as a rising imperial power 100 years ago, supplanting the decaying Spanish

Then, we fomented a war with Spain over a mysterious explosion on a US warship in Havana harbor. We proceeded to colonize Puerto Rico, Cuba and the Philippines and simultaneously annexed Hawaii. Then, the U.S. Anti-Imperialist League, led by notables like Mark Twain, failed to stop the war because they could not face the reality that we were already an empire within the continent. This time we must do better about facing, and reshaping, reality.

Otherwise the prospects are strong that Bush will lead down a path towards further acts of terror by and against the U.S. that will make September 11 pale in comparison. Think what you or I might have done had we known about the attacks in advance. Without knowing the particulars, we are facing that situation today. The responsibility is in our hands to forestall still greater calamities.

People ask "why?" about September 11, and the honest explanation is one that Bush can never provide. The answer really is simple -the perpetrators have learned the ugly lesson of "might makes right" that the US and other imperial powers have used as a guide to their behavior in the world. The wars of the last century were wars on civilians, from Kristallnacht, Stalingrad and the German V-2, through Hiroshima, No Gun Ri and My

Long before that, the wars of settlement in this country decimated and uprooted the indigenous people and took an enormous toll in Native non-combatant casualties. What happened on September 11 is ultimately no more complicated than a network of people willing to give their own treatment to the U.S., in pursuit of their objectives." Their relative powerlessness does not justify it, any more than the relative power of the U.S. justifies its acts of terror in Iraq or Yugoslavia. There has been wild speculation in response to Bush's

undocumented insistence that Bin Laden is responsible -- maybe it was really militias, Israelis, rogue elements in our own military or intelligence -- but ultimately, it doesn't matter who did it. The motivation and the potential outcome is clear -- to strike fear into our hearts, to cloud our thinking and to draw the U.S. into a protracted war. This is true whether it was carried out by Bin Laden's followers to provoke a war with Islam, or by some secret cabal in this country determined to use a war to salvage the global economy and squelch dissent.

I've heard a lot of claptrap both from the right and left about this. The right wants to look for scapegoats. Jerry Falwell and Pat Robertson blamed the disaster on gays, feminists and the ACLU for bringing down the wrath of god on the U.S. A lot of other people immediately took it into their heads to find an Arab or a Muslim to threaten, harass or even kill. In their ignorance, they have gone after Egyptian Christians, Sikhs from India. I have no doubt that some will begin attacking Jews, just like during the Gulf War.

Freedom and solidarity are indivisible. If we want to protect civilians from indiscriminate attack or communities from racial or religious prejudice, we have to extend it to everyone. The "golden rule" used to be "love your neighbor as yourself" -- until it became "he who has the gold makes the rules."

Some on the left offer half-baked explanations of their own. I've heard a lot of people saying, "terrorism is the war of the poor and weak against the rich and powerful." When you think about it for a second, that's the same b.s. Bush is putting out. If it was Bin Laden, he had no interest in the downtrodden and no program for liberation. Terror is terror, whether by the state, the racists or whoever carried out the September 11 atrocity. I have been involved with "People Against Racist Terror" for 15

years, because I know that the strong use terror against the weak all the time. That's the bully mentality. The Ku Klux Klan is historically a terrorist organization. The US waged a war of terror in Vietnam. Slave overseers and slave patrols terrorized slaves to control them and the fruits of their labor. Anti-abortion groups use terror to try to deny women their reproductive rights. Andrew Jackson terrorized the Cherokee Nation and other indigenous people out of the East Coast. Germany used terror against England, against the Jews, against the Slavs and against its own people during World War II.

The dividing line on terror is not between governments and groups that don't have state power. It's not between Christians, Muslims or Jews; nor between so-called civilized nations and alleged barbarians. The dividing line is whether or not deadly force gets used against civilians for the purpose of amassing and imposing power over them. George Bush wants to draw a line between Bin Laden and himself. If the dividing line is terror, in fact they both end up on the same, wrong side of

The enemy of my enemy is not necessarily my friend. Saddam Hussein, Milosevic or Bin Laden are no friends of oppressed people, and their program and tactics, like those of Bush, are shaped by their desire to consolidate power and impose their will.

Another contradictory set of feelings many people are gripped by is the sense that 'everything has changed" and the opposite desire to get "back to normal." The latter is a deadly tendency within us to slip back into denial and complacent arrogance. Normal is what got us into this situation. It will take an extraordinary effort -- far greater than that of the rescuers - to get us out.

Simply turning away from war, repudiating terror, is not enough. We need more fundamental change. The world did not change on September 11, but our view of the world and our place in it did. The acts of September 11 were spectacular, perhaps designed par-ticularly for a nation numbed by Hollywood depictions of terror. But US policies in Iraq alone have taken more lives, month after month for a decade -- just one of many forms of terror carried out by our government to protect "the American way of life." Even more than U.S. policy in the Middle East or Central Asia, it is the contradictions within that way of life that fuel the crisis facing us.

Our way of life is going to change; the only question is, how? Bush intends to make this a garrison state. Do we have other plans, and how can we implement them under the current circumstances? How can we transform this society so it is more sustainable and less vulnerable? We could make a start by turning the site of the now destroyed twin towers into an international peace park dedicated to the memories of the people who lost their lives. Our spirits could soar higher than the tallest building under a few trees and the open sky amid the concrete canyons. It wouldn't be a bad idea to do the same with the Pentagon.

Yet to talk of turning the Pentagon into a monument to peace is to demonstrate how basic militarism is in the U.S. Endless war and terror are the inevitable byproducts of a system based on empire. Many of us have woken up from a fantasy of invulnerability and the illusion that one can wage a onesided war, and have begun to see the consequences of empire. Remember that Pentagon war-fighting doctrine is still predicated on fighting 2.5 wars at a time Congress may have put medical insurance reform; on the back burner, but U.S. involvement in the war in Colombia continues to escalate on a daily basis even while fleets and fighter planes steam to the

### We cannot allow terror to drive us into uniting with our rulers.

There was nothing revolutionary about the September 11 attacks, but ultimately we need a revolution if we are to avoid an endless vicious cycle of attack and counter-attack. We need to de-colonize our own society and economy. Consider the repeated comments about "acts of terror on U.S. soil." Prior to this attack, the U.S. had reserved to itself the "right" to carry out terror in these territories terror against African slaves, against Native against Mexicans, against immigrants, against organized labor, against

If we want to build unity, dismantling that continental empire is a place to start. We need to oppose the militarization of police, prisons, schools and the border. They do not secure us, only the wealth and power of our exploiters.

Simultaneously, we need to think about nonstate solutions to our problems. We need to develop civilian-based defense against terror or invasion. It was civilians, for example, who stopped one of the hijacked planes from carrying out the terrorist mission while the Pentagon was stymied, itself under attack. Prevention, security measures at airports are all well and good, but the surest guarantee the Taliban, recipients of a massive aid that no such attacks can take place again is

> plane in the sky understands quite clearly the fatal consequences of the next attempt, and will act accordingly. What threat could hijackers possibly make now that would deter the passengers and crew, who know that death is inevitable in any case, from overwhelming them at any cost?

> The globalization movement provides a model for the kind of direct, person-toperson and movement-to-movement international relations we need to build, in place of the imperial war machine. We need to develop interconnected communities of resistance that can sustain themselves through war and repression. If people are panicky about terrorist attacks on nuclear power plants, perhaps it is past time to think about renewable, sustainable, non-toxic forms of energy, about reducing energy consumption and dependency on fossil fuels, not just foreign ones.

Every nuclear plant in the U.S. should be shut down, immediately and permanently. Transforming the economic system of the U.S. from one based on expansion and penetration of other societies into one based on cooperative, environmentally sound enterprise is vital. Eliminating U.S. strategic interests in the Middle East (read, "oil") would allow Arab societies to slip off the stifling yoke of reactionary regimes and colonialism.

We need to take this same approach of nonstate action to the issue of terror. Counterterrorism that uses terror will only increase the amount and level of terror in the world and in this country. If guns and bombs will only feed terror, if our own government has been guilty of terror at Wounded Knee and Hiroshima, then how do we defeat terror? By the same weapons we must use against the impulse to terror that we ourselves have just experienced. Terror is fought in a battle for hearts and minds, in a struggle against oppressive power.

Terror is fought by building solidarity. Terror must be dried out from below. Israel and the U.S. actually promoted the Muslim fundamentalist groups that turned to terror,

as part of an imperialist strategy to divide oppressed people and to blunt the dynamic of social revolutionary forces. Only by building such forces in our own society, opposing the terror of our own government, struggling for economic justice and equality, can we develop the capacity to unite with similar movements in other countries that could eliminate the sources of terror within their we must as within ours.

I shared these thoughts with a Canadian friend, Sunday Harrison with Anti-Racist Action in Toronto, and she replied, "I've been thinking about the solidarity you mention, and I think you put it well as far as what we should be encouraging people to do at home. But what about internationally? My idea (and I hope others might be thinking along these lines) is to support a broad-based fundraising campaign for an activist group of Afghan women, such as RAWA. Why not support the Afghani victims of the Taliban and Jehadis, who after all have the most interest in rebuilding their country as a secular democracy?"

The Revolutionary Association of Women of Afghanistan is operating clinics and schools, going into Afghanistan and documenting Taliban atrocities (with men who also risk their lives providing escort), at the same time as feeding their families and surviving assassination attempts. If RAWA had even a fraction of the U.S. money that will be spent on armaments, money extracted from the U.S. people whether they want it or not, the Taliban and bin Laden would be in for serious trouble. In any case, if the US goes in shooting, RAWA will still need all the help they can get. Solidarity is the antithesis of U.S. interventionism: the U.S. people (and other progressives) can take active measures to counter clerical fascism beyond our own borders, by providing such material aid."

She is right. It is only by rebuilding the solidarity and revolutionary capacity and unity of oppressed people that terror can be uprooted. Such a process of rebuilding must be self-critical. Oppressed people are not saints. Experiencing Hitler's genocide, for example, did not prevent many Jews from embracing Zionism and colonialism Within ne imperiansi system, everyone experiences a mix of oppression and privilege, whether in the form of white skin privilege or neocolonialism.

The system offers us options to surrender and incorporate ourselves into the imperialist structure by stepping on somebody else's neck. The great strength of this system, the reason it is now a global superpower, has been its capacity to capture our consent. It uses the privileges of participation in empire and settler colonialism to generate within us an identification with our own oppressors and an internalization of our own oppression. But those privileges in the form of white supremacy or neo-colonialism blind us and bind us to our own exploitation and oppression, along with that of others. The wealth and power we see around us is extracted from us and from millions around the globe.

To counter the tendencies toward either collaboration or terror, we need to emphasize the creative power of resistance. We need to develop the understanding that all the power and wealth of the oppressor's system is ed from the oppressed and exploited, used against us by virtue of our own participation in that system.

Yet the days of this system are numbered. War may defer but cannot eliminate its insoluble economic contradictions. Every globalized factory, every worker bled and sweated, every acre of stolen land, generates a productive capacity whose output can never be profitably accommodated or marketed.

Every empire in history has crumbled into dust, and this empire is no exception. That understanding, coupled with the realization that we have the capacity to create something much better in its place, will give people the hope and courage to persevere. The working, oppressed and colonized people of the world can and will unite.

No condescending saviors, no unity with our rulers! We are our own liberators!

# RACIST ATTACKS NATIONWIDE

And so it has begun. Verbal and physical attacks against Arab-Americans and Muslims and people taken for Arabs or Muslims in the United States and other Western nations are breaking out in "response" to the terrorist attacks on Tuesday. Among the various reports:

- In L.A., an Egyptian shop-keeper, a Christian, was killed. In Arizona, a man shot at a Lebanese family and an Afghan who had moved into his old house, and then shot and killed a Sikh gas station attendant who was wearing a turban and a beard. Sikhs are from India and are not Muslim. In Denton., Texas, a firebomb was hurled at the Islamic Society Center.
- Muslims at the University of Arizona have been targets of threats.
- Mohamed Al-hajri, a systems and industrial engineering junior from Qatar in the Persian Gulf, said an American student threatened him Tuesday morning. "I was going to my (8 a.m.) class," he said. "And I heard a guy screaming near the mosque. He came up, kind of scary, and he said, 'Who are you?' I was silent. I
- In Bellevue, Washington, the president of the Islamic Center of Eastside, who asked that his name not be used, said many of his members were shaken by threats they'd received. "You will all die," "Get out of this country," and "You will be treated like the Japanese were during Pearl Harbor" were among the abusive messages left on the center's answering machine, he said.
- In Australia a mosque in Mirrabooka was defiled with human feces. Also in Australia, school bus carrying Muslim children was the target of stone-throwers in Brisbane, and vandals tried to set fire to a Lebanese church in apparent acts of
- retaliation for the terrorist attacks in the U.S., officials said.
- In Suffolk County, New York, a man was arrested for allegedly making an anti-Arab threat and pointing a handgun at a gasoline station worker.
- · In Texas, at least six bullets shattered windows at the Islamic Center of Irving. Police say windows at the Islamic Center of Carrollton were also broken.
- In Fairfax County, Virginia, the All Dulles Area Muslim Society building was vandalized on Tuesday, said the American Muslim Council.

- In Asbury, New Jersey, Ramandeep Singh, a Sikh said he had rubbish and stones thrown at his car and stayed home from work.
- · Hate messages and insults were left on the answering machine of the Manassas Mosque in Virginia, said director Abu Nahidian.
- In Dearborn, Mich., Issam Koussan, owner of a local supermarket, reported that men pulled into his parking lot and yelled threats and racial slurs at his customers.
- · In Colorado Springs, a group of men threatened to burn down a mosque.
- · In Chicago, Mustafa Yassin of the Arab American Action Network said he and three others were closing the office when a middle-aged man drove by and threatened them. "He said, 'We're going to make sure you guys are going to get yours," Yassin said. In the suburban Illinois city of Palos Heights, a man was charged with a felony hate crime for allegedly attacking a gas station attendant he believed was Arab with the blunt end of a machete, police Sgt. Dave Delaney said. The attendant, who is Moroccan, didn't seek treatment, Delaney said.
- In Grand Forks, North Dakota, a Pakistani doctor was taken from the Airport and detained for four hours because he "looked suspicious."

- A mob of three hundred people were stopped by police as they tried to march on a mosque near Chicago. "I'm proud to be American and I hate Arabs and I always have," said 19-year-old Colin Zaremba, who marched with the group from Oak Lawn. Also, in Chicago a Molotov cocktail was thrown at an Arab-American community center.
- Abu Nahidian, director of the Manassas Mosque in Virginia, said his congregation has been the target of insults and hate messages left on the office answering machine.
- In Montreal, a firebomb was thrown at a local mosque.
- In Oakville, Ontario, five school children with Arabic-sounding names were assaulted.
- In the Seattle area, threats and vandalism were directed at local mosques, and several Muslims were physically attacked.
- In Gary, Indiana, a masked man fired a highpowered rifle at a gas station where Hassan Awdah, a Yemani-born U.S. citizen was at
- · A mosque in Lynnwood, Wash., was vandalized.
- In Huntington, New York a drunk tried to run over a Pakistani woman in a shopping mall parking lot. Police said Adam Lang then followed the woman into a store and threatened to kill her for "destroying my country."
- Police said an Islamic bookstore in Old Town Alexandria, Va. was vandalized Tuesday night. Someone threw bricks through 14 windows at the Islamic Center

and Mosque at Old Dominion University Tuesday evening, according to college offi-

At the same time, many Americans have phoned mosques and Islamic centers and organizations to offer support to the embattled Arab American community and have spoken out against this racial hatred. For example, in Chicago, a press conference in solidarity with Arab Americans and Muslims was convened by the American Friends Service Committee, Illinois Peace Action, the Illinois Coalition for Immigrant and Refugee Rights, the Japanese American Citizens League, the National Lawyers Guild, the Chicago Committee to

Defend the Bill of Rights, Jewish Peace Forum, Not In My Name and the Eighth Day Center for Justice. Also, Muslim, Jewish and Christian groups, including the Rev. Jesse Jackson, held a prayer vigil near the Federal buildings in down-

In Seattle, members of the Church Council of Greater Seattle met last night to condemn threats against mosques and offer to act as safety patrols "and be a presence of non-retaliation," said Executive Director Alice Woldt.

# U.S. Muslims Condemn Attack, Aid Victims

(WASHINGTON, DC - 9/11/2001) - The Council on American-Islamic Relations is calling on Muslims nationwide to offer whatever assistance they can to help the victims of today's terrorist attacks in New York and Washington, D.C.

Muslims in local communities should take the following IMMEDIATE relief agencies that are on the scene of the attacks.

CAIR also asks community members to 1) REPORT INCIDENTS of anti-Muslim harassment or attacks (Report to the police and then to CAIR. See attached "Incident Report Form.") and 2) ISSUE LOCAL STATEMENTS TO THE MEDIA (see below) condemning the attacks and offering condolences for the vic-

It is also suggested that steps be taken to increase security around mosques

and Islamic centers. (In the first few days following the 1995 attack on the

Murrah Federal Building in Oklahoma, Muslims reported more than 200 incidents of harassment, threats and actual violence.) Security precautions suggested by CAIR include:

- \* Those who wear Islamic attire should consider staying out of public areas for the immediate
- \* Request additional police patrols in the vicinity of mosques.
- \* Post mosque members at entrances and parking areas during prayer times.

- \* Report suspicious packages to police.
- \* Document descriptions of suspicious people or vehicles.

The woman's voice on the phone was as plaintive as a tear, as she implored the non-responsive talk show host to please tell her, "Why do they hate us so much? Why?".

Her voice, while not commonly projected in the current media, resonates in the consciousness of millions of Americans, who look at the carnage of the World Trade Center, shiver at the violent audacity of it, and wonder, "Why?".

This is a particularly American response, one made in a culture that has no yesterdays, and only a tomorrow of creature comforts, no-fat ice cream, and luxury cars.

History, to millions of Americans, is John Wayne, or the vaunted Founding Fathers, who have no blemishes, nor flaws. Much of the outer world are of no import, as they are subjects of the Empire, and thus expendable.

Their histories, deeply intertwined with the U.S., are of no serious consequence. Hence, the question, "Why?".

This almost willful ignorance of millions of Americans allows them to look at the bombing of the U.S.S. Cole, and the veering jet liners of 11 September, 2001, and ask, "Why?".

If you, the reader, don't want to hear an answer to this rhetorical question, feel free to turn the page, for the writer's response will not please you.

The airplane bombing of the WORLD TRADE center towers and of the Pentagon didn't begin on Sept. 11, 2001. Nor are they, as some politicians glibly suggest, "A war against civililization." But it ain't the job of politicans to inform you.

It is the job of the media, but their central concern is to sell you, and therefore they don't want to upset you. Their primary responsibility is not to their readers, but to the owners, or the stockholders. And it is the interests of the military-industrial-complex that millions remain uninformed and misinformed.

The suicide flights over New York, Washington and Pennsylvania had their

beginning in the mountainous terrain of Afghanistan, in the 10-year guerilla war against the former Soviet Union. That war was supported an facilitated by the U.S. CIA, which pumped billions into the anti-Sovie insurgency. The result? How did the Afghanis pay for the weapons, in such a poor, war-ravage country? How many know that Afghanistan is the world's greatest produce of heroin?

# THE ABORIGINAL TENT ASSEMBLY: A Letter from Aboriginal Elders to All People

by Indigenous Solidarity Action Network

Dear People

January 26, 2002 will be the 30th anniversary of the establishment of the Aboriginal Tent Embassy on the lawns of Old Parliament House, Canberra. At the Aboriginal Tent Embassy, indigenous people from the many nations continue to struggle against the system that the invaders have enforced across this continent. We have done this by taking back land from the "commonwealth" and consistently occupying this land. We have used this prime position in the parliamentary zone of Canberra to protest against the "commonwealth" government and the queen. We have fought against the imposition of British law and the export of capitalism to our country since invasion. We are the original people of this land who never ceded our sovereign rights in this country. We have held many rallies and events over the last 29 years at the Aboriginal Tent Embassy and we will continue to do so until this criminal and racist government ceases to

A large proportion of indigenous people are locked up by the white law. As a race of people we are the poorest Australians with the worst levels of health, housing, education. We are locked up for stealing because we have nothing. We are locked up for being alcoholics because we are sick with pain from being stolen from our families and kept in concentration camps such as missions, reserves and homes. We are ocked up for refusing to vote for an illegal white government. We are locked up for protesting because our people are being killed by the system. When we are in the cages of the white man we die in custody at an alarming rate.

Our laws continue to be broken as our land is torn apart by mining companies, as pastoralists, industry and developers clear the land and poison the earth, the rivers and the air. Yet these criminals walk free.

This is the extent of genocide committed by the "commonwealth" on the indigenous "australian" race. There can be no reconciliation. We at the Aboriginal Tent Embassy all on all people who support our struggle for justice and

all those who marched for reconciliation due to good intentions to join us in fighting against the government until the genocide ends. Until there is no more exploitation of the land our mother, until there is no more exploitation of any peoples in the name of economic benefit to a minority.

The "commonwealth" government plans to build a monument to reconciliation called "Reconciliation Place" at a cost of 5.5 million dollars from the "public" purse. "Reconciliation Place" is a dirty public relations exercise based on lies. In an attempt to keep indigenous "australians" in our place as an oppressed race, the "commonwealth" would ultimately like to combine the construction of "Reconciliation Place" with the removal of the Aboriginal Tent Embassy. It just doesn't fit to have in "everything is OK now we have reconciliation" monstrosity alongside a site of protest for justice for indigenous people.

# STOP GENOCIDE and Return Our Lands Through A Peace Accord

Sovereign Union of Aboriginal Nations and Peoples in Australia Speaker: Yaluritja Isaacs

To The World Conference Against Racism, Racial Discrimination, Xenophobia, and Related Intolerance

Oral intervention to Plenary, 6 September 2001, Durban, South Africa

Today I say Sorry. Sorry to the Peoples of the world that the Australian government for the last fifty years failed to implement the Genocide Convention. How many other countries are there like this? Who are they and why has this situation been tolerated so long? Let's be serious about this matter. Member States either join up or they must be thrown out.

A prerequisite to be a member State of the United Nations must include full compliance with the Genocide Convention. Personal accountability is a powerful force for change.

UBUNTU! UBUNTU! I call for unity among Indigenous Peoples and UN member States to address this insult to humanity.

We propose an international Indigenous Peace Accord for Land Rights and Sovereignty and for Kofi Annan and Mary Robinson to support our call for a Special Rapporteur on Genocide in Australia.

The 1992 the High Court Mabo judgement threw out Australia's claim to sover-eignty, the lie of terra nulllius, replacing it with an "Act of State", which is only a doctrine, not international law. The Mabo case admitted that domestic legal systems can not determine the sovereignty of Aboriginal Peoples. Only the International Court of Justice can do this. We argue that if the UN is serious about ending racism it should take the ndigenous sovereignty issue out of the debate and refer it to the International Court of Justice for an advisory opinion.

Our resolve is to claim back our sovereign identity and our traditional lands and cultural heritage, with a clear unrestricted right to maintain our religious and spiritual practices.

If all Australians had the same living experiences as Aboriginals, a third of them would not be alive today. We addressed many UN Committees in search of remedies. CERD [Committee on the Elimination of All Forms of Racial Discrimination] placed Australia on "early warning and urgent action". Nothing improved. Since 1999 CERD condemned the Native Title Act as racist, as it validates non-Indigenous title to land, while depriving us of our inheritance. It is only a bundle of residual rights, not proper land rights.

Justice Kirby in the High Court said that the Australian Constitution is racist, like Nazi Germany and South Africa under apartheid. Australia has repossessed the apartheid policy, which they once sold to South Africa, and welcomes the foot soldiers, who left South Africa on the "chicken run". Australia is celebrating the Centenary of its Constitution, which is an Act of the British Parliament. In 1901 the National Interest was defined for the "Aryan race and the Christian faith". The Queen in 1954 personally signed the Aborigines Ordinance, which forcibly removed our people off their lands in Canberra.

On 11 and 12 September in Canberra High Court, in Wilson-v-Anderson, we welcome international lawyers and observers to witness these proceedings, where the government-funded National Farmers Federation is challenging the Native Title claim of Michael Anderson, the co-ordinator of SUANPA, who was prevented from being here, because this case was scheduled immediately after this conference.

# The Trans-Atlantic Slave Trade, Slavery and Colonialism

Much has been said over the past few days, weeks, months and years about the Trans-Atlantic slave trade, slavery, colonialism and apartheid, crimes against humanity; whether acknowledged as so by the United Nations or not. Permit us here to prove that they were and remain Pan-African and International in their scope and impact.

The Trans-Atlantic slave trade began in Africa. not in the America's as so many forces incorrectly proclaim. According to the UNESCO Slave Trade Project, the Museum of the Atlantic Slave Trade, and the Harvard Database on Slave Voyages, between 28 and 42 million African people were captured and enslaved between 1441 and 1888. Fourteen to twentyone million Africans, one half of all captives, two women to every man, were enslaved in Africa. Four to six million Africans, 40% of all captives and slaves, were murdered or died along the entire "way of death" which included the wars of conquest in the interior of Africa, the forced march to the sea, the period of incarceration in the forts and castles along the coasts, and during the Middle Passage. Ten to fifteen million of these African slaves, two men for every woman, were landed alive in the Americas.

Portugal and Brazil, Great Britain and France kidnapped, transported and sold more than 9,643,600 or 87.4% of the landed African slaves. They were responsible for the death of 3,857,440 additional African slaves. Holland, Spain, the United States, Canada and Denmark, Scandinavia and Germany kidnapped, transported and sold more than 1,418,900 or 21% of the landed African slaves. They are collectively responsible for the death of 567,560 additional African slaves. The Vatican sanctioned, legalized and benefited from the Trans-Atlantic slave trade, slavery and colonialism as well. The records exist, and the facts speak for them-

selves

For over 400 years, for more than twenty generations, Western Europe and their colonies in the Americas invaded, pillaged, raped and destroyed countless African villages, societies and civilizations in at least eight major regions of Africa, including: Senegambia, Sierra Leone, the Windward and Gold Coasts, the Bight of Benin, the Bight of Biafra, West Central Africa and South East Africa. For more than 400 years, for more than twenty generations, Western Europe and their colonies in the Americas murdered and raped, kidnapped and enslaved tens of millions of African people in Africa, and transported them to, murdered and enslaved them in at least 15 major areas in the Americas.

Without the Trans-Atlantic slave trade and slavery, the European colonization of Africa and the Western Hemisphere would have been difficult, if not impossible. Colonialism, settler-colonialism, neo-colonialism and apartheid, crimes against humanity, existed for an additional 100 years after the formal end of slavery in Africa and the African Diaspora, and continue to exist in Africa and the African Diaspora today, albeit in contemporary manifestations and forms.

All moral and reasonable women and men must acknowledge that these crimes against humanity have no statue of limitations. All moral and reasonable women and men must admit that these crimes against humanity have had and continue to have a tremendous impact, (economic, social and political) on Africa; the African Diaspora and the world. All women and men of morality and reason must therefore accept that reparations is the order of the day!

### On Reparations, the Debt and Aid

We have demonstrated the Pan-African and International scope and impact of the Trans-Atlantic slave trade, slavery, colonialism, settler-colonialism, neo-colonialism and and we pray that it will declare the Trans-Atlantic slave trade, slavery and conialism crimes against humanity, with no statues of limitation, and in so do make a meaningful and lasting impact on the world-wide struggle agaracism, racial discrimination, xenophobia and related intolerance, include caste-based discrimination.

Perhaps here, we should remind the United States and Israeli governments, United Nations and ourselves, that it is the people, through the leadership of t popular and revolutionary movements and organizations who make history, the governments of the world, not the United Nations, and not even the Non-gernmental Organizations. The struggle therefore continues and intensifies!

# U.S. Boycott of Racism Conference is nothing new.

The U.S. government's withdrawal from the third World Conference Against Racism is consistent with its role in the two previous international conferences on racism. It boycotted those, too.

A review of history reveals that the United States has failed to use its influence as a world super power to support the 29-year campaign of the United Nations against racism and racial discrimination.

### First Decade: 1973-1982

In November, 1972, the U.N. General Assembly designated 1973-1982 at the First Decade to Combat Racism and Racial Discrimination. The United States did not participate in the first decade, and the administration of President Jimmy Carter did not send a delegation to the first WCAR, held in Geneva in 1978. (Since he left the White House, Carter has become an international crusader for human right rights.)

Just as it has been at the Durban conference, the Middle East conflict was a contentious issue at the first WCAR. Indeed, in 1975, three years before the 1978 conference, a majority vote of the General Assembly approved a resolution that "Zionism is a form of racism."

If this sounds familiar, that's because it is the same language that on Monday caused the United States and Israel to walk out of the Durban WCAR.

Regarding the first WCAR, a majority of delegates supported draft language in the conference's declaration that was critical of discrimination against Palestinians. As a result, several delegations from Western countries walked out of the conference.

Second Decade: 1993-1992

In December, 1982, the General Assembly designated 1983-1992 as the Second for Action to Combat Racism and Racial Discrimination. Part of Program of Action for the second decade focused on the elimination of S African apartheid, which the General Assembly condemned as "the extreme form of racism."

President Ronald Reagan opposed the decision of the U.N. Security Councimpose economic sanctions against South Africa, but Congress forced him talong with it.

There was no U.S. delegation at the second WCAR, held in 1983 in Vis Apartheid was a major topic of discussion.

### Third Decade: 1993-2002

In 1994, 25 years after the United Nations approved the Internation Convention on the Elimination of All Forms of Racial Discrimination. United States ratified it. The 155 governments who have signed ICERD pl to fulfill several legal obligations, one of which is to report every two years the U.N. Committee on the Elimination of Racial Discrimination, which is sees the implementation of the ICERD.

People who believe they are victims of racial discrimination in countries have ratified the ICERD may file complaints directly to the CERD. Although the United States has approved ICERD, it did so with qualifications, saying it will not be bound by any parts of ICERD that are protected by the constitution and the laws of the United States.

The United States was instrumental in the creation of the United Nation 1945. Today, 56 years later, the American government has once again turned back on one of the most crucial tasks of the United Nations—the eliminational forms of racism and related intolerances.

# Reflections on the World Conference Against Racism

After an 18-hour flight of over 11,000 miles from Durban to Johannesburg to Cape Verde to New York to Los Angeles, I am back. I am bleary-eyed and probably spastic, but much wiser and informed from the tremendous experiences of the World Conference Against Racism and its sister conference, the NGO Forum.

The Middle East crisis will not be solved by the World Conference Against Racism, nor should anyone have expected it to. However, language was found and agreed upon that was at least mutually tolerable concerning two hot-button issues: the Zionism/Palestinian confrontation, and on the "slavery as a crime against humanity" issue.

# What did blacks in the US get out of the WCAR and the NGO Forum?

- We participated on a world stage with several thousand other groups, organizations and individuals.
- We gave voice to several perceptions of harm being done internationally to women, caste groups, national groups, apartheid victims, etc.
- We represented ourselves well. The Conference Declarations and Programs of Action are to be put into various implementation projects worldwide, and we had significant input. We rallied, demonstrated, negotiated, and communicated with the best and worst of them, and we showed some skills and aplomb at international protocol, diplomacy and analysis. As African Americans we were not marginalized at these two conferences, although the US government relentlessly attempted to do that to us.
- We networked broadly and grandly. We now know of reparations advocates in Brazil, Jamaica, Belize, Tanzania, France, Senegal, Columbia, Zimbabwe, Cuba, Libya, South Africa, etc.

growing international movement is, and a closer scrutiny of the depth of the opposition. The United Council of Churches was there, so were several Presbyterian groups, and the United Methodists as advocates of reparations for African and African Americans. Black American church groups were conspicuous by their absence.

- We gave primary recognition and re-introduced o urselves to a whole slew of heroes and sheroes in this effort: Jamaica's 85-year-old Dudley Thompson, who is a superb negotiator; December 12th's Viola Plummer and Roger Wareham; Fidel Castro; Adjoa Aiyetoro; the Black Political Leadership Forum; N'COBRA; the National Black United Front; reparations lawyer Charles Ogletree; Danny Glover and Harry Belafonte; and the Africa and African Descendants Caucus, to name but a few.
- We learned once again that rhetoric and passion simply are not, and will not be, enough if victory, rather than merely noise and publicity, is our real goal. We've got to hit the books and records hard and develop tight, tight arguments. The European Union came to the WCAR coordinated with denials, excuses and counter-arguments for virtually everything we had, and they ran a strong tag-team assault on our reparations positions in virtually every commission, every

The Dalits, the dark-skinned people of India, the Roma (gypsies) of Europe, and many other issues got an airing.

The continuingly negative news reports to the contrary were simply mistaken. (There were over 1,000 journalists/media people at both conferences, and they had to have something to write home about everyday. (Negative news is always easier news.)

The WCAR, slow and plodding as it was, got on with its business, and cannot be adjudged a failure at any level, save the common denominator problem with housing accomodations courtesy of Turners Travel and Tours (the single company assigned by the S.A. government to handle accomodations for over 15,000 guests in a city with only 6,000 registered hotel/bed 'n breakfast units). Turners, in a word, was not equal to the task.

meeting and every discussion. If we plan on running with and conquering the big dogs of this particular war, we better get our stuff very much together, and we are clearly not yet there.

- We attended and frequently participated in many of the hundreds of panel discussions and information forums presented at the WCAR. There were too many great ones to name here, but a new UNESCO historical project on the Slave Trade Routes, Peoples, Issues and Resolutions was presented (mostly in French, with excellent work by the translators). Other issues included: A full elaboration of the May 2001 French law that declared the Trans-Atlantic Slave Trade a crime against humanity and promised future discussions on possible compensation; racism and the media; issues of women's status in relation to racism, sexism other forms of intolerance; racism in the criminal justice system in international perspective; racism in Japan, were some of them. The learning opportunities at both conferences were immense.
- We got a clearer vision of what this is all about and what we have to do.
- We learned, again, about the perils of little or no communication between allies in a major battlefront. We handicap ourselves and sap our own strength. Too often, one group of African

Americans was doing one thing, while another group operated as if it was fighting alone, and another acted as though it was the only group that counted and that could speak for us all: altogether sometimes confusing issues and negotiating partners unnecessarily, and all sometimes cancelling each other's efforts and bard work.

- We learned that we are not alone and we have some permanent friends.
- We learned that we better choose our own leaders and spokespeople better, or they will anoint themselves to our detriment. Rev. Jackson, for example, did a lot of speaking for us without consulting any of us, and he did not always get it right.

I have "tons" of paper and documents that I have to sort through and organize for some public presentations back in L.A. And yes, I do have quite a few pictures (at least, I think I do; the security scans which we had to go through at least 50 times, hopefully didn't zap them).

First, however, I need some sleep. -

# RACISM AND POLICE MURDER IN THE U.S.

Statement to the International Thematic Commission on Racism in the Criminal Justice Systems, The International Criminal Justice Caucus, World Conferece Against Racism, Xenophobia, and Religious Intolerence, gathered in Durban, South Africa, 09/06/2001

To: Chairperson and panel members

My name is Lorenzo Komboa Ervin. I am at this conference representing the Black Autonomy International. We have in turn created a network of local groups in the State of Michigan (in the USA) which primarily organizes around racism, police brutality and racial profiling, called the Southwest Michigan Coalition Against Racism and Police Brutality. It should be noted at the outset, that the city of Detroit leads the United States in the number of police shootings and deaths in custody (over 100 since 1991).

Although the U.S. government refuses to report on the exact number of persons killed by police use of deadly force each year (NOTE: as it is in fact mandated by the 1994 Criminal Code revision), we have been able to document 500-1,000 cases per annum of police fatalities filed to the U.S. Department of Justice, but only through the work of local grassroots groups like ours, national activist groups like the October 22nd Coalition, and others.

Through these organizations and our own efforts, we have learned that there are thousands of cases of police shootings of racial minorities, some of which often prove fatal in the United States. In addition, numerous other Black and other non-white persons lose their lives each year after beatings, strangulations and other violent methods used by American law enforcement authorities. There is also widespread racial profiling by American police agencies, who stops hundreds of thousands of innocent raical minority group persons upon the streets of American cities and highways, some of which stops have turned into deadly provocations, fatal shootings, and

other encounters.

Even where there are no deaths, racial profiling caused daily humiliation and/or has resulted in illegal imprisonment and torture. For instance, in Kalamazoo, Michigan, it was discovered last year that over 25 black males had been illegally arrested on minor offenses, and then stripped naked at the jail, and made to remain that way for hours on end. In New York city, similar "naked jailing" cases involved over 60,000 black and Latino citizens, and there are such cases all over the country. This humiliation and torture many times precede the tragic loss of life.

Even though there are civil rights and criminal codes in the United States which allegedly protect racial minorities and could be used to punish excessively violent police offenders, they are invariably not implemented if the accused is a law enforcement officer and the victim is a racial minority. Neither the investigation by the Federal Bureau of Investigation (the agency used to perform "independent" investigations by the U.S. Dept. of Justice, or a civil rights lawsuit by the family will go in their favor. They are left without any satisfaction at all because of legal obstacles and judical collusion with police.

The case of Mr. Wadie Suttles is a case in point: Mr. Suttles, a 66 year old African American grandfather, was arrested without legal cause in Chattanooga, Tennessee during the Christmas season of 1983. He was immediately beaten by the arresting officer, and then taken to jail where he was beaten several times and ultimately killed by a truncheonn-wielding Officer Mike Williams and other officers of the Chattanooga Police Department. Almost immediately, when the family and activist members of the black community demanded answers, they were met with stonewalling and lies by local officals, and inaction by the Federal Bureau of Invesstigation, who covered up his death for years. When the family filed a lawsuit in 1984, the city government officials claimed not to know how he was killed, but

claimed invariably that it was a "suicide", "heart attack", or other "natural method" of death, when they knew for a fact he had died by homicide. The judge, a political appointee of the Ronald Reagan administration named R. Allen Edgar, conducted a sham civil rights trial, and promptly threw the case out. Then the family conducted a 15 year campaign for justice, through a civil rights group they had helped to create, called the Concerned Citizens for Justice. But although the local authorities knew full well that this man was unlawfully killed while in police custody, no one has ever been arrested or prosecuted in this matter. Mr. Suttles' case is typical of what the families of the victims of police murder routinely go through in the USA: lies, evasions, and a criminal coverup. The fact is that generally the American federal government will not put police officers in jail for killing racial minorities.

Even though there are U.N. international codes of conduct for law enforcement officers and an international covenant on police use of deadly force, none of this has stopped the killings in the USA, primarily because of the fear of the international community to pressure the only remaining superpower. Thus, the U.S. government stands defiant to any international law as it benefits the Black and other minorities. The government only uses international law when it can gain tactical advantages in an international dispute with another nation or the United nations as a body. It does not see itself bound in anyway to an international criminal code, or the UN code of conduct for law enforcement officers.

Thus, what I am saying is that the USA is an outlaw nation, a white supremacy regime, hiding under the erstwhile cloak of democracy and human rights (for the white population only), while it uses its law enforcement agents to practice state terrorism against the Black population and those of other racial minorities. It is a government which withdrew from any participation in this conference and has boycotted the

two previous U.N. conferences on racism and racial discrimination, in 1978 and 1983 respectively.

It uses its court system to railroad numerous poor and racially oppressed national groups into the prisons of the U.S. and even into the death chambers, where many have been killed in both an unlawful and immoral fashion. Just last year, it executed a clearly innocent man, Shaka Sankofa in the State of Texas, and Mumia Abu Jamal has sat on death row in the State of Pennsylvania for the last 20 years as the result of a severely flawed criminal prosecution, where his race and past political associations were used to convict him. He is not guilty of any crime other than being an outspoken Black militant and journalist, who criticized the Philadelphia Police Department for its routine use of excessive force against the Black community. The governor, and other high officials of the state personally know he is not guilty, but continue to hold him in prison because of racism and political expediency. it is an example of the kind of pernicious white racism which saturate the American criminal justice system.

The country which postures as the champion of human rights is guilty of genocide, racism, and torture. Police agents are allowed to torture, kill and illegally detain racial minorities throughout the country. Neither the individual states or the federal executive branch have vigorously prosecuted any officer for committing murder while in uniform. Rather, it has shown them the greatest deference.

We came here to Durban hoping that this conference will apply sanctions against the U.S. government, and/or obtain an agreement forcing it to abide by international law on the use of deadly force by law enforcement officers. If it can do that, then our coming to the WCAR will be well worth it. Thank you.

# FIDEL CASTRO SPEAKS at the **WORLD CONFERENCE AGAINST RACISM**

Key address by Dr. Fidel Castro Ruz, President of the Republic of Cuba at the World Conference against racism, racial discrimination, xenophobia and related intolerance in Durban, South Africa.

September 1, 2001

Excellencies:

Delegates and guests:

Racism, racial discrimination and xenophobia are not naturally instinctive reactions of the human beings but rather a social, cultural and political phenomenon born directly of wars, military conquests, slavery and the individual or collective exploitation of the weakest by the most powerful all along the history of human societies.

No one has the right to boycott this Conference which tries to bring some sort of relief to the overwhelming majority of mankind afflicted by unbearable suffering and enormous injustice. Neither has anyone the right to set preconditions to this conference or urge it to avoid the

The inhuman exploitation imposed on the Likewise, peoples of three continents, including Asia. marked forever the destiny and lives of over 4.5 billion people living in the Third whose poverty, unemployment, illiteracy and health rates as well as their infant mortality, life expectancy and other calamities --too many, in fact, to enumerate here-- are certainly awesome and harrowing. They are the current victims of that atrocity which lasted centuries and the ones who clearly deserve compensation for the horrendous crimes perpetrated against their ancestors and peoples.

Actually, such a brutal exploitation did not end when many countries became independent, not even after the formal abolition of slavery. Right after independence, the main ideologists of the American Union that emerged when the 13 colonies got rid of the British domination at the end of the 18th century, advanced ideas and strategies unquestionably expansionist in nature.

white settlers of European descent, in their march to the West, forcibly occupied the lands in which Native- Americans had lived for thousands of years thus exterminating millions of them in the process. But, they did not stop at the boundaries of the former Spanish possessions; consequently Mexico, a Latin American country that had attained its independence in 1821, was stripped off millions of square kilometers of territory and invaluable natural resources.

Meanwhile, in the increasingly powerful and expansionist nation born in North America, the obnoxious and inhumane slavery system stayed in place for almost a international century after the famous Declaration of Independence of 1776 was issued, the same that proclaimed that all men were born free That rich and squandering world is in and equal.

After the purely formal slave emancipation, African- Americans were subjected during one hundred more years to the harshest racial discrimination, and many of its features and consequences still persist after almost four more decades of heroic struggles and the achievements of the 1960's, for which Martin Luther King, Jr., Malcolm X and other outstanding fighters gave their lives. Based on a purely racist rationale, the longest and most severe legal passed sentences are against African-Americans who in the wealthy American society are bound to live in dare poverty and with the lowest living standards.

what is left of the Native-American peoples, which were the first to inhabit a large portion of the current territory of the United States of America, remain under even worse conditions of discrimination and neglect.

Needless to mention the data on the social and economic situation of Africa where entire countries and even whole regions of Sub-Saharan Africa are in risk of extinction the result of an extremely complex combination of economic backwardness, excruciating poverty and grave diseases, both old and new, that have become a true scourge. And the situation is no less dramatic in numerous Asian countries. On top of all this, there are the huge and unpayable debts, the disparate terms of trade, the ruinous prices of basic commodities, the demographic explosion, the neoliberal globalization and the climate changes that produce long draughts alternating with increasingly intensive rains and floods. It can be mathematically proven that such a predicament is unsustainable.

It was based on such ideas that the ancient The developed countries and their consumer societies, presently responsible for the accelerated and almost unstoppable destruction of the environment, have been the main beneficiaries of the conquest and colonization, of slavery, of the ruthless exploitation and the extermination of hundreds of millions of people born in the countries that today constitute the Third World. They have also reaped the benefits of the economic order imposed on humanity after two atrocious and devastating wars for a new division of the world and its markets, of the privileges granted to the United States and its allies in Bretton-Woods, and of the IMF and the financial institutions exclusively created by them and for them.

discussion of historical responsibility, fair compensation or the way we decide to rate the dreadful genocide perpetrated, at this very moment, against our Palestinian brothers by extreme right leaders who, in alliance with the hegemonic superpower, pretend to be acting on behalf of another people which throughout almost two thousand years was the victim of the most fierce persecution, discrimination and injustice that history has known.

Cuba speaks of reparations, and supports this idea as an unavoidable moral duty to the victims of racism, based on a major precedent, that is, the indemnification being paid to the descendants of the Hebrew people which in the very heart of Europe suffered the brutal and loathsome racist holocaust. However, it is not with the intent to undertake an impossible search for the direct descendants or the specific countries of the victims of actions occurred throughout centuries.

The irrefutable truth is that tens of millions of Africans were captured, sold like a commodity and sent beyond the Atlantic to work in slavery while 70 million indigenous people in that hemisphere perished as a result of the European conquest and colonization.

There are enough funds to save the world from the tragedy

May the arms race and the weapon commerce that only bring devastation and death truly end.

Let it be used for development a good part of the one trillion US dollars annually spent on the commercial advertising that creates false illusions and inaccessible consumer habits while releasing the venom that destroys the national cultures and identities.

May the modest 0.7 percentage point of the Gross National Product promised as official development assistance be finally delivered.

May the tax suggested by Nobel Prize Laureate James Tobin be imposed in a reasonable and effective way on the current speculative operations accounting for trillions of US dollars every 24 hours, then the United Nations, which cannot go on depending on meager, inadequate, and belated donations and charities, will have one trillion US dollars annually to save and develop the world. Given the seriousness and urgency of the existing problems, which have become a real hazard for the very survival of our specie on the planet, that is what would actually be needed before it is too late.

Put and end to the ongoing genocide against the Palestinian people that is taking place while the world stares in amazement. May the basic right to life of that people, children and youth, be protected. May their right to peace and independence be respected; then, there will be nothing to fear from UN documents.

I am aware that the need for some relief from the awful situation their countries are facing has led many friends from Africa and other regions to suggest the need for such prudence as would allow something to come out of this conference. I sympathize with them but I cannot renounce my convictions, as I feel that the more candid we are in telling the truth the more ibilities there will be to be beeded and

respected. There have been enough centuries of deception:

I have only three other short questions based on realities that cannot be ignored.

The capitalist, developed and wealthy countries today participate of the imperialist system born of capitalism itself and the economic order imposed to the world based on the philosophy of selfishness and the brutal competition between men, nations and groups of nations which in completely indifferent to any feelings of solidarity and honest international cooperation. They live under misleading, irresponsible hallucinating atmosphere of consumer societies. Thus, regardless the sincerity of their blind faith in such a system and the convictions of their most serious statesmen, I wonder: Will they be able to understand the grave problems of today's world which in its incoherent and uneven development is ruled by blind laws, by the huge power and the interests of the ever growing and increasingly uncontrollable independent transnational corporations?

Will they come to understand the impending universal chaos and rebellion? And, even if they wanted to, could they put an end to racism, racial discrimination, xenophobia and other related issues, which are precisely the rest of them all?

From my viewpoint we are on the verge of a huge economic, social and political global crisis. Let's try to build an awareness about these realities and the alternatives will come up. History has shown that it is only from deep crisis that great solutions have emerged. The peoples' right to life and justice will definitely impose itself under a thousand different shapes.

I believe in the mobilization and the struggle of the peoples! I believe in the idea of justice! I believe in truth! I believe in man!

# **National Security Archive Releases** September 11<sup>th</sup> Sourcebooks

The horrific September 11th terrorist attacks on the World Trade Center and the Pentagon brought all of us here at the National Security Archive feelings of rage at the hijackers, of grief for the thousands who were murdered, and also of determination that we will contribute to finding the best ways for America to respond. The Archive's mission is to put on the record the primary source documentation that can enrich the policy debate, improve journalism, educate policy-makers, and ensure that we don't reinvent the wheel or repeat the mistakes of the past.

To these ends, we begin today by publishing the first volume in a series called The September 11th Sourcebooks. We have cast a wide net, because the policy debate itself is also ranging widely, from deployment options abroad to wiretap surveillance at home. The first volume contains the documents that our staff experts, led by Dr. Jeffrey Richelson and coordinated by Michael Evans, have selected as the most important available primary sources on U.S. terrorism policy. These materials include CIA biographic sketches of Usama Bin Laden and Taliban leader Mohammad Omar, reports from the Pentagon and the Senate Intelligence Committee on previous terrorist attacks on the USS Cole and the Khobar Towers, the State Department's overview of global terrorism and the FBI's review of terrorism in the U.S.

## Treatment of Immigrants within the United States

At the request of Attorney General John Ashcroft, INS Commissioner James Ziglar today (September 18) signed an "administrative" order expanding the time the INS may detain immigrants while it investigates whether they have violated any immigration laws or regulations. At the same time, the Justice Department announced today that it has detained 75 "immigrants" for "questioning" in last week's terrorist attacks on the World Trade Center and Pentagon. Forty-nine immigrants were detained as of yesterday, twenty-six more were detained today. At this rate, hundreds of immigrants could be detained for "questioning" in the coming weeks, and perhaps thousands in the coming months.

As Attorney General Ashcroft made clear in his announcement today, the Immigration and Naturalization Service (INS) now possesses far greater powers. It can jail immigrants indefinitely in "extraordinary circumstances," even though the people detained are

# Aiding Vieques amid the madness

I wish hope and strength to you in these very difficult days. I am writing to ask for your collaboration in the continuing struggle for peace and justice for Vieques, particularly how it is playing out in Even before the attacks of September 11, decision-making in Congress and the White House regarding the Navyls bombardment of Vieques was at a critical point. It still is.

In the current climate, it will be easier for those who see war or militarism as a solution to the world1s ills to institute far-reaching measures that contradict our best values. An alternative vision to war as a response to attack encompasses the need to respect the ecology and basic human rights of those affected by bombing practice in Vieques. We cannot overcome terror by inflicting it.

It is also important to note that such practice is ineffective in defending people from terrorist attacks. The day after the attacks, Admiral Kevin

# **Ending Racism in Medicine**

NEWPORT BEACH, CA (thehealthchannel.com) - In a speech to academic researchers and healthcare executives, Dr. Rodney Hood, president of the National Medical Association (NMA), called on the medical community to focus more aggressively on the persistent gap in quality of care faced by the nation's minorities.

The NMA, which represents more than 25,000 African-American physicians, has been a consistent voice in the call for more parity in care for minority groups in the U.S.

Hood noted that each year 35 percent more African Americans die from cancer than the general population, and 40 percent more die from heart

"Nobody is talking about these excess deaths," he said. "Little effort has been made to address these disparities through organizational quality improvement."

# Political Prisoners Held Incommunicado

Minutes after the September 11 attacks on the Pentagon and World Trade Center, several political prisoners and POWs were forcibly taken out of general population and thrown into Security Housing Units. They were classified as Administrative Segregation, and detained officially "for investigation." Included in the roundup were at least Tom Manning, Carlos Alberto Torres, Marilyn Buck, Sundiata Acoli, Richard Williams, and Father Philip Berrigan. Tom Manning and Father Berrigan have both been released, but the others remain in detention.

In an unprecedented development, the political prisoners remaining in segregation have been denied ALL ACCESS to the outside world. Even their lawyers are denied contact with them - no legal visits nor legal mail is allowed. All social visits have been cut off. These prisoners are not being allowed access to the telephone, and are not allowed to receive mail. When lawyers and outside supporters called the prison to protest these developments, prison staff told them that it was "for the protection of the inmate."

Clearly these political prisoners had no involvement with the World Trade Center or Pentagon attacks, so what is the BOP "investigating?" These prisoners have been in prison for more than 15 years, with all outside contact rigidly controlled by the prison system. They are only allowed to call approved telephone numbers, and all calls are monitored and recorded. Visitors are subjected to extra-rigorous screening; all legal and social visits are monitored. Outgoing mail is photocopied, and incoming mail is read and copied as well.

These comrades were kidnapped and put in isolation allegedly for their "protection," but it is the U.S. government and Bureau of Prisons who have endangered their lives by consistently labeling them as "terrorists" to inflame public opinion against them. Other prisoners and even staff know that the political prisoners help mediate disputes between prisoners and are always helpful and willing to advocate for prisoners' individual and collective rights.

All the prisons where the lockdowns have occurred deny responsibility for these actions. Lawyers for the political prisoners have confronted wardens and regional prison staff seeking the origin of these unprecedented policies. They have been told that the directive came "from the highest levels of the Department of Justice," probably the office of the Attorney General. It remains unclear why only some of the political prisoners and prisoners-or-war held in U.S. prisons have been targeted. # **ANTI-ARAB ATTACKS CONTINUE**

Washington, DC, Sept 21- A number of troubling new instances of hate crimes trary exclusion of passengers due to race, ethnicity or religion. Clearly it is and discrimination against Arab Americans and Muslims, or those perceived to be, unfolded across the country today. In seven separate instances in cities including Tampa, Orlando, Minneapolis, and San Antonio, pilots or passengers caused Arab American or Muslim passengers, who had passed through rigorous security checks and been seated, to be expelled from the aircraft simply on the grounds of their apparent ethnicity. And an Arab American was killed in Michigan in an apparent act of vengeance for the Sept. 11 attacks.

In one instance, three Arab American men were expelled from Northwest flight 673 from Minneapolis to Salt Lake City at the insistence of other passengers, because of their ethnicity. When the other passengers refused to fly if the three remained on board, Northwest expelled the Arab Americans from the plane. A Northwest spokesman has been quoted as saying, "Under FAA security rules, the airline has no choice but to re-accommodate a passenger or passengers if their actions or presence make a majority of passengers uncomfortable and threaten to disrupt normal operations of flight." In other cases, such as that in Orlando, where two businessmen from Pakistan were expelled from a flight they had boarded, it was the pilots who insisted on passengers' expulsion due to perceived ethnicity.

ADC appealed to the Federal Aviation Administration (FAA) and Justice Department to promptly issue guidelines clarifying that neither pilots authority nor passenger sentiments could be grounds for excluding passengers simply on the basis of ethnicity or religion. ADC President Ziad Asali said "when the FAA regulations were promulgated they were not intended as a vehicle for the arbiunacceptable that passengers are expelled from aircraft because someone, even the pilot, just doesn't like the way they look. The FAA needs to clarify its rules regarding the expulsion of passengers based on perceived ethnicity.

Elsewhere, what is at least the third hate crime murder since Sept. 11 occurred in Lincoln Park, Michigan, just outside Detroit. The victim, a 45 year old US citizen originally from Yemen, was shot 12 times in the back by his girlfriend's former lover. According to the suspect's own

police confession and the girlfriend's statements, as the two were sleeping, her former boyfriend broke in and dragged the Arab American out of bed, saying "I'm going to kill you for what happened in New York and DC." The victim ran outside and was killed. The attacker is in custody and has made a full confession. ADC has received assurances from the FBI and Justice Department that anti-Arab hate crimes will be vigorously investigated.

# Not in Our Son's Name

Our son Greg is among the many missing from the World Trade Center attack. Since we first heard the news, we have shared moments of grief, comfort, hope, despair, fond memories with his wife, the two families, our friends and neighbors, his loving colleagues at Cantor Fitzgerald / ESpeed, and all the grieving families that daily meet at the Pierre Hotel.

We see our hurt and anger reflected among everybody we meet. We cannot pay attention to the daily flow of news about this disaster. But we read enough of the news to sense that our government is heading in the direction of violent revenge, with the prospect of sons, daughters, parents, friends in distant lands dying, suffering, and nursing further grievances against us. It is not the way to go. It will not avenge our son's death. Not in our son's name.

Our son died a victim of an inhuman ideology. Our actions should not serve the same purpose. Let us grieve. Let us reflect and pray. Let us think about a rational response that brings real peace and justice to our world. But let us not as a nation add to the inhumanity of our times.

Dear President Bush:

Our son is one of the victims of Tuesday's attack on the World Trade Center. We read about your response in the last few days and about the resolutions from both Houses, giving you undefined power to respond to the terror attacks.


